2. Eligibility

You must be at least 18 years old to use the App.

By using PetMeeter, you confirm that:

- you are at least 18 years old

 - you will comply with all applicable laws

By uploading content, you grant PetMeeter a worldwide, non-exclusive, royalty-free license to host, store, display, reproduce, and use the content solely to operate and improve the App.

We may remove or moderate content at our discretion.

6. Matching & Chat Conduct

Messaging is only available after a mutual match.

You agree to communicate respectfully and responsibly.

Strictly prohibited behavior includes:

- harassment
- threats or abuse

- scams or fraud
- spam
- illegal activity
- inappropriate or explicit content

PetMeeter may suspend or permanently terminate accounts that violate these rules.

7. Prohibited Activities

You agree NOT to:

- impersonate another person

 - promote breeding, selling, or trading animals commercially
 - scrape, hack, disrupt, or reverse engineer the App
